

The applicant has given list of trustees in his application. The applicant stated the mode of succession of trustee, the object of the trust, particulars of property of the trust in his application. He stated that the property bearing No. 2674 in Survey No. 17/1 to the extent of 1450 Sq. Meters situated at village Mouje Karegaon is within the jurisdiction of Grampanchayat, Karegaon, as described in the application is the trust property. The consent letter of the trustees is filed on record. The applicant prays that the application be allowed.





- After filing the present application public notice has been issued as per Rule 7A of The Maharashtra Public Trusts Rules, 1951. The copy of news paper is filed on record at Exh. 11. The Process Server also has filed his report with *'panchanama'* below Exh. 04 to 08.
- 03) After issuance of public notice nobody has objected the application, therefore the inquiry is uncontested.
- The applicant also has filed consent letter of trustees at Exh. 02, copy of tax assessment register (Exh.12), no objection (Exh.10) letter issued by Grampanchayat, Karegaon and verified copy of notice and minutes of meeting. The applicant also filed original registers in respect of issuance of notice and minutes of meeting on record.
- Heard leanned counsel for the applicant today. He submitted that the trustees are devotees of the 'temple'. He submitted that 'Bhavsar Sahakari Housing Society' has developed plots in Survey No. 17/1 situated at village Karegaon and duly Non Agricultural order has been obtained. Thereafter, in a open space of the said housing society, after taking no objection from the concerned local authority the temple is constructed. All the necessary documents has been filed on record. He submitted that for religious purpose the trust be registered.
- Perused the documents on record and consider the submissions of the applicant. According to the Sec. 19 of The Maharashtra Public Trusts Act, 1950 and Rule 6 of The Maharashtra Public Trusts Rules, 1951; following points arise for my determination

# -: REASONS :-

## As to Point No. 01:

07) The applicant stated that the object of the trust is religious in nature. The trust is formed for religious purpose i.e. पुजा—अर्चा, भजन किर्तन, गायन, दिवाबत्ती, ई. After issuance of public notice nobody has objected to the registration of the trust. On perusal of notice and minutes of meeting, it appears that the trust is formed and there are seven trustee of it. So, it appears that it is a trust and considering its objects it is a public trust. Hence, I answer point no. 01 in the affirmative.

#### As to Point No. 02:

Exh. 12. On perusal of Exh. 12 it appears that the property is mutated in the name of temple in the record of Grampanchayat, Karegaon. The said Grampanchayat also has given no objection certificate to form the Trust in respect of the said temple, it is filed below Exh. 10. Nobody has objected to the application. Hence, I hold that the property is of the trust. Hence, I answer point No. 02 in the affirmative.

#### As to Point No. 03:

09) The trust is situated at village Karegaon which is within the jurisdiction of Parbhani Region, therefore subject matter of the trust is within the jurisdiction of this Public Trusts Registration Office.

# As Point No. 04 to 11, 13 & 14:

10) Gone through the application. It appears that the applicant has filed the application within the format provided as per Rule 6 of The Maharashtra Public Trusts Rules, 1951 in Schedule - II. The applicant has provided necessary particulars in respect of names, addresses of trustees and manager, mode of succession, objects of the trust, gross average annual income, expenditure and source of income of the trust in the application itself. The applicant also filed the documents creating the trust. - 3. Certificate of registration be issued to the applicant.
- 4. Trustees are directed to submit the Scheme relating to the administration of the Trust.
- 5. Necessary entries be taken in Schedule I as in Rule 5 of The Maharashtra Public Trusts Rules, 1951.
- 6. The original register be returned to the applicant.
